- f. To do all such acts as may be necessary or incidental for the furtherance of the objects and activities of the Trust.

The trust shall be an irrevocable public educational, cultural trust for the benefit of all persons belonging to whatever community irrespective of Caste, Creed or Religion, the Trustees shall stand possessed of the said amount of corpus endowed by the Authors of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

#### Board of the Trustees:

The Trust shall be administered and managed by a Board of Trustees consisting of as many Trustees as may be decided by the Managing Trustee from time to time, provided that the Board of Trustees shall not consist of less than two and not more than Seven Trustees at any time.

The Author of the Trust shall be the First Managing Trustee. As long as the Author is the Managing Trustee, He shall hold the office of Managing Trustee.

The Board of Trustees shall Co-opt, with the consent of the Managing Trustee, other Trustees who shall hold office for a period of their Life Time from the date of appointment.

Vacancies in the office of Trustees due to retirement, resignation, death or otherwise, shall be filled by the board of trustees with the consent of the Managing Trustee and the Trustees so co-opted shall hold office for two years but would be eligible for co-option.

Vacancy in the office of the Managing Trustee shall be filled by election by the Board of Trustees then in office. A Managing Trustee elected shall hold office for a term of two years and shall be eligible for re-election.

In the event of having only Two trustees in the board at any time the appointment of other trustees will be made by Consensus. If there is any difference of opinion in the appointment of other trustees, between subsisting two trustees, the Founder / Managing trustee will have a 'Casting Vote' in addition to the vote as trustee. In the absence of the Founder / Managing trustee, the eldest of the trustee in age will act as managing trustee with a casting vote for the time.

b) No person shall hold or continue to hold office or be appointed as a trustee and the trustee's office shall be vacated ipso facto.

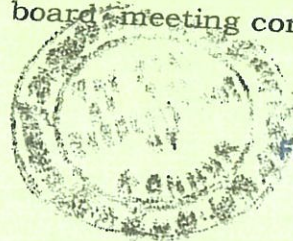
- i) If he or she is found to be or become a person of unsound mind.
- ii) If he or she is convicted of an offence involving moral turpitude.
- iii) If he or she is adjudged as an insolvent.
- iv) If he or she is or become deaf-mute.

- vii) If he or she is otherwise disqualified to act according to law to which he is a subject for the time being in force.

Whenever any person appointed as a trustee of the trust hereby created disclaims or any such trustee either original or substituted dies or is for a continuous period of fifteen months absent without leave of the board from the Indian union or leaves the Indian union for the purpose of residing abroad or desires to be discharged from the trust or refuses or becomes in the opinion of majority of his or her co-trustees unfit or personally incapable to act in the trust or is disqualified in terms of the provisions of clause 8 supra, a new trustee shall be appointed in his place by the Board

### Powers of the Board of Trustees:

The Board of Trustees shall have full power and authority to administer and manage the Trust, its institution and Properties and funds and to do all acts, deeds and things which promote the objectives for which the Trust is established.

Without prejudice to the generability of the foregoing the board of Trustees shall have the power and authority for the purpose of the Trust:-

- a) All property of the Trust Movable or Immovable or of <sup>Any other kind</sup> to be acquired in future ~~any other kind~~, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.
- b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:
  - i. To acquire, hold, dispose of properties movable, immovable, rights and privileges, stocks, securities and shares to be acquired in future.
  - ii. To mortgage, grant on lease, hire or otherwise alienate the properties of the Trust to be acquired in future with the prior approval of the Income Tax Authorities wherever necessary.
  - iii. To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.
  - iv. To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.

- v. To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.
- vi. a) To raise loans with or without security and repay the same, to receive monies, securities or other movable property on behalf of the Trust.  
b) To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.
- vii. To award scholarship and make donations calculated to promote the objects of the Trust.
- viii. To enter into contracts, or engagements on behalf of the Trust.
- ix. To open and operate bank accounts in any scheduled bank or banks as the Trustees may deem fit from time to time.
- x. To consider such proposals submitted by Sub-committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
- xi. To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.
- xii. To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
- xiii. To sell, transfer or otherwise dispose of any immovable property to be acquired in future of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
- xiv. To raise monies from the Public by organizing benefit performances, collection of subscriptions and donations, bringing out publications and in other ways.
- xv. To institute, prosecute and defend all suites, legal and other proceedings in the name of the Managing trustee.
- xvi. To appear before courts, Tribunals, Government, tax and other public authorities.
- xvii. To appoint a Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.
- xviii. To appoint consultants or other individuals, such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
- xix. To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.

- xx. To frame Bye-Laws and such other regulations as are required for achieving its objectives.
- xxi. Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely
- (a) All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
  - (b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
  - (c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
  - (d) The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
  - (e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
  - (f) Cost and expenses of keeping the trust property in good condition.
  - (g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
  - (h) The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.
  - (i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto. After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees

**Powers of Managing Trustee:**

The Founder / AUTHOR shall be the chief executive officer of the board and as such he / she shall have power and authority for and on behalf of the board.

- A. To carry out the resolutions of the board.
- B. To sign papers, receipts and accounts.
- C. To pay money due by the trust and demand and get receipts there for the money so paid.
- D. To demand and receive money due to the trust and issue receipts for the money so received.
- E. To open current and deposit accounts in the name of the trust with the bank or banks from time to time authorized in this behalf, to deposit the funds of the trust in such accounts on behalf of the trust.

- F. To make, draw, endorse, sign, negotiate or transfer cheques, promissory notes, bills of exchange, bills of lading, railway receipts, warrants and other negotiable or transferable instruments, Government securities or other securities.
- G. To lease out for a period not exceeding three years at a time, lands and properties of the trust which are ordinarily leased out.
- H. To initiate, prosecute, defend, compromise to arbitration or abandon legal proceedings or disputes and to sign all papers in connection there with.
- I. To appoint, employ, remunerate, remove, suspend, dismiss reemploy, replace, transfer and accept resignation of staff and workers permanently, temporarily or otherwise.
- J. To call for the meeting or meetings of the board and
- K. To execute all documents on behalf of the board.

#### **BANK ACCOUNT:**

(i) The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of the Trust such accounts shall be jointly operated by the Managing Trustee and Treasurer

(ii) The trust may open Bank Account/s in the name of **Astraa Global School** institution/organisation founded by the Trust. Such Bank Accounts shall be operated by such persons as authorised by the board of trustees from time to time.

#### **Remuneration of Trustees:**

The office of the Trustees and Managing Trustee shall be honorary and any person holding such office shall not be entitled to draw any remuneration for carrying out his duties. However they may be reimbursed the whole or part of the actual expenses incurred by them while discharging their duties as may be determined by the Board of Trustee from time to time.

#### **TRANSACTION OF BUSINESS BY THE TRUSTEES AND QUORUM:**

- a) The Trustees may meet as often as may be necessary for the conduct of the business of the Trust and at least once in six calendar months.
- b) The meeting may be called and convened by the Managing Trustee as and when he deems necessary to transact the business of the Trust and the Managing Trustee shall be the Chairperson for the meeting.

- c) In the case of absence of the Managing Trustee, the remaining Trustees shall elect a chairman for that meeting.
- d) The quorum for the Board of Trustees shall be Four. All decisions shall be taken by majority of votes. In case of equality of votes, the chairperson of the meeting shall have a casting vote.
- e) When there is no quorum for any meeting at the scheduled time, then the Managing Trustee of the Chairman of the meeting as the case may be, shall adjourn the meeting to another date and for such adjourned meeting the Trustees present subject to a minimum of Two shall constitute the quorum.
- f) All the business of the Trust may also be transacted by circulation of papers.
- g) The administration, direction, management of several institution and establishment in terms of the trust hereby created shall be subject to the supervision, control and direction of the Managing trustee. In the event of any difference of opinion, the Managing trustee shall be bound by the decision of the majority of the board
- h) The funds of the trust derived from the sum and investments of the said funds as set out infra.
- i) In any of the securities authorized by section 20 of the Indian Trusts Act, 1882.
- ii) In the purchase of acquisition of land or buildings or other immovable properties provided that no such investment shall be made except with the previous sanction of the board recorded by means of a resolution passed at a meeting of the board.
- iii) In current or savings bank or fixed deposits with banks or Governments and in the modes and forms specified under the provisions of the Income Tax Act and Rules made there under as approved by board by means of a resolution recorded at the meeting of the board.

- j) The board shall have power to accept contributions, money or property by way of addition to the trust funds generally or for any one or more of the specified objects of the trust and in either case such contributions shall be deal with either as capital or as income according to the directions of the donors at the time of the gift.
- k) Except as otherwise provided herein, none of the trustee for the time being of the trust shall have power jointly or severally to mortgage or change on any of the trust properties.

- o) The grants -in-aid shall be strictly applied for the purpose for which they may be received from Government and other agencies and the board may advice the Founder / Managing trustee to apply the grants for the purposes for which they may be applied for and received.
- p) Whenever for the administration of the trust hereby created for the establishment, development and conduct of the several institutions maintained hereunder, Grants-in-aid from Government are applied for the

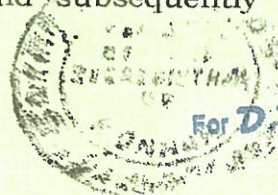


objects and it becomes necessary for the due performance of the conditions of such mortgages or charges or all or any of the trust properties or facilities to facilitate the obtaining of such grants for purchase of lands and for administrations and conduct and maintenance of such institutions.
